

RESOLUTION NO. 121 — 69

**Adoption of Local Law, Intro. No. 2—69, Print No. 1 Providing for
Establishing the Annual Salaries of Certain County Officers**

Offered by: Supervisor Harland Hale

Resolved:

1. That proposed Local Law Intro. No. 2-69, Print No. 1 is hereby adopted without any change in language, to wit:

Be It Enacted by the Board of Supervisors of the County of Allegany as follows:

Section 1. Commencing January 1, 1970, the annual salary of the County Judge shall be the sum of Twenty-nine thousand one hundred fifty dollars (\$29,150.00).

Section 2. Commencing January 1, 1970, the annual salary of the Commissioner of Social Services shall be the sum of Thirteen thousand one hundred forty dollars (\$13,140.00).

Section 3. Commencing January 1, 1970, the annual salary of the County Superintendent of Highways shall be the sum of Eleven thousand dollars (\$11,000.00).

Section 4. Commencing January 1, 1970, the annual salary of the County Treasurer shall be the sum of Eleven thousand dollars (\$11,000.00).

Section 5. Commencing January 1, 1970, the annual salary for each Commissioner of Elections shall be One thousand seven hundred and sixty dollars (\$1,760.00).

Section 6. Commencing January 1, 1970, the annual salary of the Commissioner of Jurors shall be One thousand two hundred and seventy dollars (\$1,270.00).

Section 7. Commencing January 1, 1970, the annual salary for each Commissioner of Civil Service shall be Six hundred and sixty dollars (\$660.00).

Section 8. Commencing January 1, 1970, the compensation for county coroners shall be at the rate of twenty-seven dollars and fifty cents (\$27.50) per diem in the performance of their official duties.

Section 9. This local law which is subject to permissive referendum shall take effect upon the date it is filed in the Office of the Secretary of State.
