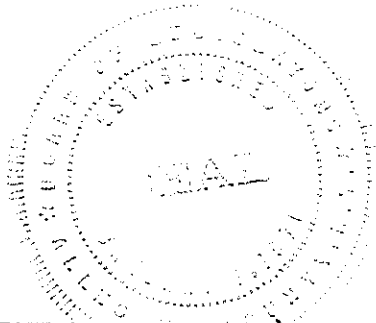
- 1. That proposed Local Law, Intro. No. 12 - 77, Print No. 1, is hereby adopted without any change in language, to wit:

A LOCAL LAW TO PROVIDE THE PAYMENT OF TWO HUNDRED DOLLARS ON AN ANNUAL BASIS TO CERTAIN COUNTY OFFICERS WHO HAVE COMPLETED OR MAY COMPLETE TEN YEARS OF SERVICE DURING THEIR TERM OF OFFICE

BE IT ENACTED by the Board of Legislators of the County of Allegany as follows:

Section 1. Each person who holds on the effective date of this local law an appointment to a full-time county office for a fixed term and who has completed on the effective date of this local law or does complete before the expiration of such fixed term and after the effective date of this local law at least ten years of continuous full-time county employment, shall receive, from the effective date of this local law if such ten years have been completed or from such date of completion if such date of completion falls after the effective date of this local law to the termination date of his or her current term of office, the sum of two hundred dollars on an annual basis. Such sum shall be in addition to any sum or sums which such person is receiving pursuant to local law number one of nineteen hundred and seventy-two and local law number six of nineteen hundred and seventy-four.

§ 2. This local law shall take effect on the date it is filed in the Secretary of State's Office.
