News Release:

The Allegany County Department of Health (ACDOH) was notified of positive cases of residents, positive cases of employees, and deaths of positive cases from the five Allegany County nursing homes and/or assisted living facilities.

*No updates reported this week from Highland Park.

Manor Hills Assisted Living facility reported that 32 of their 57 positive residents have recovered. All 8 of their positive employees have recovered and returned to work.

We are sad to report to our residents and community a total of thirty-four deaths in Allegany County from COVID-19. Sixteen deaths are reported to be associated with the Houghton Rehabilitation and Nursing Center. Thirteen* deaths are reported to be associated with the Highland Park Rehabilitation and Nursing Center. Two deaths are reported to be associated with Wellsville Manor Center. The other three deaths are not related to one of these facilities and are from the Allegany County community (one of these deaths was previously reported in March). The thirty-four deaths were:
