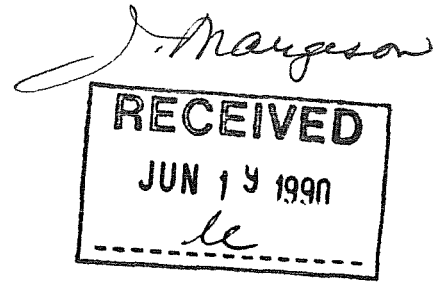

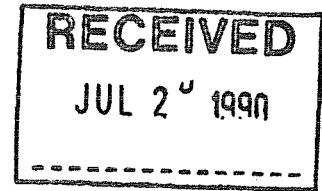

SYNOPSIS OF GOVERNOR'S BILL ON L.L.R.W.

- \* increases membership of Siting Commission from 5 to 7 by adding "an environmentalist who represents a non-profit environmental organization" and " a private citizen who shall be Chairperson"
- \* requires that Commission "evaluate all reasonable alternative disposal methods" and "issue a report of its' evaluation"
- \* requires that the disposal method be selected before the site is selected. Attendant to selection of disposal method will be an environmental impact statement.
- \* requires the Commission to issue a report detailing what lands are to be excluded from siting consideration and why.
- \* major decisions relative to the selection of disposal method, site characterization and pre-characterization and specific data regarding L.L.R. waste (volume, activity, types, etc) shall be promptly accompanied by narrative reports.
- \* calls for the establishment, via contract by and with the NYS Department of Health, of an independent panel or panels of technical and scientific experts who shall review and evaluate Commission decisions.
- \* requires the Commission to make available all computerized data generated by its' staff and contractors, when obtainable pursuant to article six of Public Officers Law.
- \* calls for the creation of a "citizens advisory committee" made up of:
  - two representatives of non-profit environmental organizations,
  - two Health Physicists or Medical Doctors knowledgeable of radiological health effects,
  - two representatives of L.L.R.W. generators,
  - one private citizen technically competent concerning L.L.R.W.
  - one private citizen knowledgeable of L.L.R.W. and experienced in agricultural production



- one private citizen from local Public Health services knowledgeable of L.L.R.W.
  - one private citizen who is an elected local governmental representative of each county in which a candidate site has been identified.
- \* The Commission must "recommend a site specific mitigation program as part of the environmental impact statement that will serve as an additional measure to offset adverse economic, social and environmental impacts and serve as a form of compensation to the affected area."
- \* The Citizens Advisory Committee shall:
- meet at least bi-monthly to provide information and review activities of the Commission and DEC,
  - receive written reports from the Commission, DEC and NYSERDA as to the "plans and progress" in carrying out the L.L.R.W. Management Act,
  - provide information and recommendations in response to the Commission's Draft Environmental Impact Statements relative to final site and disposal method selection,
  - hire an Executive Director and clerical support
  - facilitate the public reviews and comment process concerning
    - the disposal method selection process,
    - the site selection process,
    - site characterization,
    - matching the selected disposal method to the final site
    - the draft Environmental Impact Statement.
  - exercise and perform other advisory functions related to the Commission's activities and those of DEC.



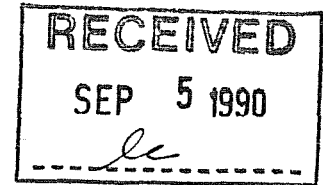

There being no further business to discuss, the meeting was adjourned.

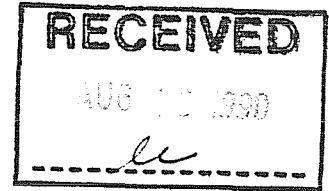

Discussion was held on the request for a new Janitor position in the Buildings account. County Attorney prepare resolution as follows:

Discussion was held with Charles Benjamin on the request in the Health Department budget of one new Registered Nurse position and one new Public Health Technician position. A motion was made by Frair, seconded by Boyce and carried to approve these new positions.

With regard to the new part-time position of E.I.S.E.P. Coordinator in the Office for the Aging, this was approved on a motion by Frair, seconded by Cross and carried.

The new laborer position in Solid Waste was discussed. No action taken at this time as the Budget Officers will work with Public Works Superintendent to work out a compromise with regard to other possible cuts in the budget.

Also included in the Social Services budget were two new CAP Specialist positions. This was tabled.

Mr. Mulholland and Mr. Wentworth stressed to the committee that a decision must be made as to whether the county will be going to the bond market to cover certain capital costs, such as the bridge construction and equipment, or whether these costs will have to be included in the budget. A motion was made by Cross, seconded by Reuning and carried, that these capital items be covered by issuing bonds. (Voting No: Saylor, Faulkner).

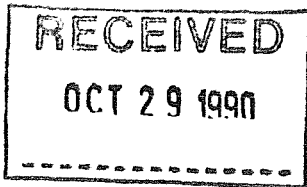

Regarding the three new positions in the Public Works budgets, i.e., 1 Janitor, 1 Laborer and 1 H.M.E.O., a motion was made by Nielsen, seconded by Gallman and carried, that the Public Works Department and Committee be requested to re-evaluate the need for these positions.

With regard to the two new positions in the Health Department budget, i.e. 1 Registered Nurse and 1 Public Health Technician, a motion was made by Gallman, seconded by Saylor and carried, that the Health Services Committee and Health Administrator, re-evaluate the need for these positions.

With regard to the two new CAP Specialist positions included in the Social Services budget, as well as three positions for the JOBS Program which are not presently included in the tentative budget, a motion was made by Watson, seconded by Miess and carried, that all of these positions be re-evaluated by the Social Services Committee and the Commissioner as to the need for these positions. It was decided that the result of all of the above evaluations should be presented



by the various committees to a meeting of the Committee of the Whole to be held at 11:00 a.m. on November 13th, prior to the regular meeting of the Board.

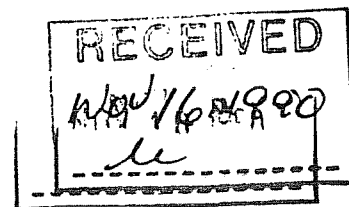
Legislator Walchli commended the Budget Officer and Deputy Budget Officer on the work they had done on the tentative budget.

This meeting was called to discuss several new positions which are included in the 1991 county tentative budget and to hear from the committees of jurisdiction as to their evaluation of the need for these positions.

Legislator Sylor, Chairman, Public Works Committee, addressed three new positions in the Highway, Solid Waste and Buildings divisions of the Public Works Dept. Mr. Sylor noted that all three positions had been evaluated by the Public Works Committee and approval was given that they remain in the budget. He explained that the H.M.E.O. position was needed to complete the crew for the new bridge maintenance truck. The Laborer position in Solid Waste was needed at the Wellsville transfer station to handle recyclable materials and a Janitor position in the Buildings division would be assigned a Wednesday through Sunday work week for normal janitorial duties as well as to eliminate considerable overtime, particularly on week-ends when the buildings must be checked. A motion was made by Sylor, seconded by Allen and carried unanimously that the H.M.E.O. position be retained in the 1991 budget. A motion was made by Allen, seconded by Boyce and carried that the Laborer position for Solid Waste be retained in the 1991 budget. (Voting No: Gallman, Loucks and Miess). A motion was made by Cross, seconded by Allen and carried, that the Janitor position be retained in the 1991 budget to work a Wednesday through Sunday work-week. (Voting No: Gallman, Loucks, Reuning, Walchli and Watson).

Legislator Frair, Chairman, Health Services Committee, addressed two new positions included in the Health Department budget for 1991. During a meeting of the committee with Mr. Benjamin, Health Director, Mr. Benjamin noted that he could not say for sure whether or not the Registered Nurse position was needed until the completion of a final evaluation he is conducting in his department. This may not be finished for another three months. The committee recommended that this position be eliminated. A motion was made by Frair, seconded by Gallman and carried, that the Registered Nurse position be eliminated from the budget and appropriation Account No. A4010.1 be reduced by \$18,617 and revenue Account No. A3401 be reduced by \$7,446. Also discussed was the Public Health Technician position in the budget. Mr. Benjamin was willing to eliminate this position on the understanding that he be given approval to fill a vacant budgeted Public Health Sanitarian position. This was approved on a motion by Frair, seconded by Boyce and carried, with appropriation Account No. A4010.1 reduced by \$16,352 and revenue Account No. A3401 reduced by \$6,541. Mr. Benjamin also requested that funds for a part-time Typist position be included in his department budget for 1991. This is needed due to the Office Manager being on maternity leave for a year and that position being filled on a temporary basis from within the department, leaving insufficient clerical help. A motion was made by Frair, seconded by Boyce and carried, that funds for this part-time Typist

position be included in the 1991 budget and that appropriation Account No. A4010.1 be increased by \$6,500 and revenue Account No. be increased by \$2,600. (Voting No: Loucks).

Legislator Allen, Chairman, Social Services Committee, addressed several positions in the Social Services Dept. The first was the request for two CAP Specialists, funds for which were included in the budget. It has been determined since the budget was prepared that one of these positions can be eliminated. A motion was made by Allen, seconded by Watson and carried, to eliminate one CAP Specialist position and to reduce appropriation Account No. A6011.1 by \$21,897 and to reduce revenue Account No. A3611 by the same amount. (Voting No: Gallman).

The second request from Social Services is to include three new positions related to the JOBS Program, one Senior Caseworker and two Caseworkers, as well as equipment in the amount of \$2,500. The Social Services Committee has approved this request. A motion was made by Allen, seconded by Boyce and carried, to include one Senior Caseworker and two Caseworkers in the 1991 budget and to increase appropriation Account No. A6010.1 by \$51,229 and to increase State Aid revenue Account No. A3610 by \$12,807 and to increase Federal Aid revenue Account No. A4610 by \$25,615. (Voting No: Gallman, Loucks, Miess, Reuning, Saylor, Walchli).

A referral from Public Works Committee was considered, to reinstate the sum of \$10,000 to the Solid Waste account No. A8160.436 - Recycling which is to be used to fund an education program in conjunction with Cooperative Extension. A motion was made by Palmiter, seconded by Cross and carried, that this \$10,000 be restored to Account No. A8160.4. (Voting No: Faulkner, Gallman, Loucks, Reuning and Walchli).

Legislator Frair asked for consideration to provide funds to Mercy Flight per their request. Following discussion, a motion was made by Watson, and seconded by Reuning, that we do not support the request for funds for Mercy Flight. (Voting No: Boyce, Cross, Faulkner, Frair, Miess, Walchli and Wentworth). Motion defeated.

Mr. Frair also discussed the request from Health Systems Agency of Western New York for support from Allegany County in the amount of \$3,900. No action was taken.

Meeting adjourned.
