

RESOLUTION NO. 186-70

TITLE: ADOPTION OF LOCAL LAW, INTRO. NO. 3-70, PRINT NO. 1 PROVIDING FOR ESTABLISHING THE ANNUAL SALARIES OF CERTAIN COUNTY OFFICERS

RESOLVED:

1. That proposed Local Law Intro. No. 3-70, Print No. 1 is hereby adopted without any change in language, to wit:

BE IT ENACTED by the Board of Legislators of the County of Allegany as follows:

Section 1. Commencing January 1, 1971 the annual salary of the Commissioner of Social Services shall be the sum of Thirteen Thousand Eight Hundred Eighty Dollars (\$13,880.00).

Section 2. Commencing January 1, 1971 the annual salary of the Director of Planning shall be the sum of Thirteen Thousand Two Hundred Dollars (\$13,200.00).

Section 3. Commencing January 1, 1971 the annual salary of the County Superintendent of Highways shall be the sum of Twelve Thousand Two Hundred Dollars (\$12,200.00).

Section 4. Commencing January 1, 1971 the annual salary of the County Attorney shall be the sum of Twelve Thousand Dollars (\$12,000.00).

Section 5. Commencing January 1, 1971 the annual salary of the County Treasurer shall be the sum of Eleven Thousand Seven Hundred Dollars (\$11,700.00).

Section 6. Commencing January 1, 1971 the annual salary of the Commissioner of Jurors shall be the sum of One Thousand Three Hundred Fifty Dollars (\$1,350.00).

Section 7. This Local Law, which is subject to permissive referendum, shall take effect upon the date it is filed in the Office of the Secretary of State.
