

RESOLUTION NO. 147-76

TITLE: ADOPTION OF LOCAL LAW INTRO. NO. 4-76, PRINT NO. 1, ESTABLISHING AN INDUSTRIAL AND COMMERCIAL INCENTIVE BOARD

RESOLVED:

- 1. That proposed Local Law, Intro. No. 4-76, Print No. 1, is hereby adopted without any change in language, to wit:

A LOCAL LAW IN RELATION TO ESTABLISHING AN INDUSTRIAL AND COMMERCIAL INCENTIVE BOARD

BE IT ENACTED by the Board of Legislators of the county of Allegany as follows:

Section 1. There is hereby established an industrial and commercial incentive board for the county of Allegany pursuant to subdivision eight of section four hundred eighty-five-b of the real property tax law.

§ 2. Such board shall advise the Allegany County Board of Legislators, at such time or times as the Board of Legislators may require, of the exercise of the Board of Legislators' options available pursuant to subdivision seven of section four hundred eighty-five-b of the real property tax law. Such board shall also review the economic conditions of the county of Allegany and make recommendations on the basis of such review to the Board of Legislators with respect to actions it deems desirable to improve the economic climate within said county. Such board shall also possess such powers and duties as may be prescribed by the Board of Legislators.

§ 3. Such board shall consist of five members who shall be appointed by and serve at the pleasure of the Board of Legislators. A member shall continue to hold office until his successor is appointed and has qualified. Such board shall select its own chairman and such other officers it desires from its members. The members of such board shall receive no compensation for their services, but shall be entitled to the necessary expenses, including travel expenses, incurred in the discharge of their duties.

§ 4. This local law shall take effect on the date it is filed in the office of the secretary of state.
