GENERAL GUIDELINE FOR HAZARDOUS MATERIALS INCIDENTS

APPROACHING THE SCENE:

APPROACH THE SCENE FROM UPWIND AND UPHILL

DO NOT DRIVE THROUGH A VAPOR CLOUD

DO NOT DRIVE THROUGH ANY SPILLED MATERIAL

DO NOT LET THE APPARATUS BECOME A SOURCE OF IGNITION

POSITION THE APPARATUS TO ALLOW FOR QUICK RETREAT

ADVISE ALLEGANY FIRE CONTROL TO NOTIFY THE HAZ-MAT
COORDINATORS

ARRIVING AT THE SCENE:

DESCRIBE THE SCENE IN YOUR INITIAL REPORT.

SIZE-UP THE INCIDENT AND REQUEST HELP SUCH AS: HAZ-MAT TEAM(S), CHEMICAL HAZARDS INFORMATION TEAM (CHIT), ALLEGANY COUNTY HEALTH DEPARTMENT, ALLEGANY COUNTY DEPARTMENT OF PUBLIC WORKS, NYS POLICE HAZ-MAT ENFORCEMENT UNIT, ETC.

IF THERE IS AN IMMEDIATE LIFE THREATENING SITUATION OR SEVERE PROPERTY THREATENING SITUATION SOME IMMEDIATE REMEDIAL ACTION MAY BE NECESSARY. OTHERWISE, RESIST THE URGE TO RUN IN AND DO SOMETHING. KEEP IN MIND: IF LITTLE IS TO BE GAINED, THEN LITTLE SHOULD BE RISKED.

DO NOT BE IN A HURRY. TAKE YOUR TIME TO DO THINGS SAFELY AND CORRECTLY.

FIRST AID: MOVE PATIENT TO FRESH AIR. REMOVE CONTAMINATED CLOTHING AND FLUSH PATIENT WITH WATER.

STAY UPWIND. KEEP OUT OF LOW AREAS.

AVOID BREATHING VAPORS, FUMES OR SMOKE.

DO NOT ASSUME MATERIAL TO BE HARMLESS BECAUSE OF THE LACK OF SMELL.

DO NOT TOUCH OR WALK THROUGH ANY SPILLED MATERIAL.

MOVE AND KEEP UNNECESSARY PEOPLE AWAY. SET UP A PERIMETER TO ISOLATE THE HAZARD AREA. DENY ENTRY.

FIREFIGHTERS ARE PEOPLE TOO. UNLESS THEY ARE PERFORMING AN ASSIGNED AND NECESSARY TASK, KEEP THEM OUT OF THE HAZARD AREA.

IF SPILLED MATERIAL OR RUN-OFF IS IN DANGER OF SPREADING: ATTEMPT TO CONTAIN IT BY DIKING WELL AHEAD OF THE SPILL. COVER SEWER DRAINS.

SETUP A COMMAND POST AND DESIGNATE AN INCIDENT COMMANDER.

IDENTIFY THE MATERIAL:

FIND OUT WHAT MATERIAL IS BEFORE EXPOSING PERSONNEL.

TALK TO PEOPLE AT THE SCENE: TRUCK DRIVER, PLANT OPERATOR, ETC.

USE BINOCULARS TO VIEW PLACARDS, LICENSE PLATE, VEHICLE IDENTIFICATION INFORMATION, AND TYPE OF CONTAINER.

OBTAIN SHIPPING PAPERS.

OBTAIN MATERIAL SAFETY DATA SHEET.

USE FIRE DISPATCHERS TO CONTACT: CHEMTREC, SHIPPER, CARRIER, CONSIGNEE, MANUFACTURER, ETC.

IF ABOVE FAILS, IT MAY BE NECESSARY TO SEND TWO (2) FIREFIGHTERS INTO THE HAZARD AREA TO COLLECT INFORMATION.

CORRECT SPELLING OF THE CHEMICAL IS CRITICAL.

OBTAINING HAZARD & HANDLING INFORMATION:

FIND OUT WHAT THE HAZARDS OF THE CHEMICAL ARE BEFORE EXPOSING PERSONNEL.

FIND OUT WHAT THE PHYSICAL AND CHEMICAL PROPERTIES OF THE MATERIAL ARE BEFORE EXPOSING PERSONNEL.

USE REFERENCE BOOKS.

USE PEOPLE AT THE SCENE WHO MAY BE FAMILIAR WITH THE CHEMICAL.

USE FIRE DISPATCHERS TO CONTACT: CHEMTREC, SHIPPER, CARRIER, CONSIGNEE, AND MANUFACTURER.

USE ALLEGANY COUNTY HEALTH DEPARTMENT REPRESENTATIVE.

USE NYS POLICE.

USE LOCAL CHEMIST SUCH AS "CHIT": CHEMICAL HAZARDS INFORMATION TEAM.

CLEANING UP THE HAZARDOUS WASTE:

THE FIRE DEPARTMENT'S JOB AT A HAZARDOUS MATERIALS INCIDENT IS TO MITIGATE THE EMERGENCY. THIS MAY INVOLVE SUCH ACTIONS AS EVACUATION OF ENDANGERED PERSONS, EXTINGUISHMENT, CONTAINMENT, NEUTRALIZATION, AND CONTROL OF THE RELEASED MATERIAL. A HAZARDOUS MATERIALS RESPONSE TEAM SHOULD ALSO HAVE THE CAPABILITY TO CLEAN UP SMALL SPILLS OF APPROXIMATELY 50-100 GALLONS.

THE CLEAN-UP OF BOTH LARGE AND SMALL SPILLS CAN BE ACCOMPLISHED BY A COMMERCIAL CLEAN-UP COMPANY. WHILE THESE COMPANIES DO NOT OFFER A THREE MINUTE RESPONSE TIME, THEY ARE EQUIPPED, TRAINED AND EXPERIENCED IN HANDLING HAZARDOUS MATERIALS.

THE SPILLER WILL BE HELD FINANCIALLY RESPONSIBLE FOR THE CLEAN-UP. THEREFORE, IT IS THE SUPPLIER, NOT THE FIRE DEPARTMENT, WHO MUST CONTACT THE CLEAN-UP COMPANY.

DECONTAMINATION:

EQUIPMENT AND PERSONNEL SHOULD BE DECONTAMINATED AT THE SCENE.

RUN-OFF FROM DECONTAMINATION SHOULD BE COLLECTED AND DISPOSED OF WITH OTHER HAZARDOUS WASTES.

DISPOSAL OF HAZARDOUS WASTES:

THE JOB OF THE FIRE DEPARTMENT IS TO MITIGATE THE EMERGENCY. WHILE IT IS SOMETIMES DIFFICULT TO SAY EXACTLY WHEN THE INCIDENT STOPS BEING AN EMERGENCY, THE LINE IS GENERALLY DRAWN SOMEWHERE AFTER CLEAN-UP HAS STARTED AND BEFORE DISPOSAL BEGINS. ONE POINT, HOWEVER, IS CLEAR: THE FIRE DEPARTMENT SHOULD NEVER TRANSPORT OR DISPOSE OF HAZARDOUS WASTES.

ALLEGANY COUNTY FIRE CONTROL CENTER STANDARD OPERATING PROCEDURES INCIDENTS INVOLVING HAZARDOUS MATERIALS

PURPOSE:

THIS STANDARD OPERATING PROCEDURE IS TO BE USED FOR INITIAL AND EXTENDED RESPONSES TO HAZARDOUS MATERIALS INCIDENTS INVOLVING TRANSPORTATION AND FIXED SITE FACILITIES IN ALLEGANY COUNTY, THE PROCEDURE INTERFACES WITH OTHER COUNTY AGENCIES TO FORM A COMPREHENSIVE COUNTY HAZ-MAT RESPONSE PLAN.

SCOPE OF RESPONSIBILITY:

IF THE INCIDENT COMMANDER DECLARES A **LEVEL I INCIDENT** OR IF FIRE CONTROL RECEIVES THE INITIAL CALL, THEN PROCEED AS FOLLOWS:

- 1) UPON NOTIFICATION OF A LEVEL I INCIDENT:
 - A) **RESPOND LOCAL FIRE AND RESCUE UNITS TO THE SCENE!**
 - B) NOTIFY FIRE COORDINATOR/ Emergency Manager
 - C) ADVISE RESPONDING UNITS THAT HAZARDOUS MATERIALS MAY BE INVOLVED. NOTIFY HAZ-MAT COORDINATORS.
 - D) COMPLETE INCIDENT REPORT FORM.

IF FIRE AND POLICE UNITS MAKE A DETERMINATION OF A **LEVEL II OR LEVEL III INCIDENT**, FOLLOW LEVEL I NOTIFICATIONS ABOVE AND THE FOLLOWING:

- 2) UPON NOTIFICATION OF A LEVEL II OR LEVEL III INCIDENT:
 - A) NOTIFY THE FIRE COORDINATOR AND DISTRICT DEPUTY FIRE COORDINATOR.
 - B) NOTIFY THE REGIONAL DEC AT 1-800-457-7362.
 - C) NOTIFY CHEMTREC AT 1-800-424-9300 AND GIVE INFORMATION RECEIVED ON INCIDENT TECHNICAL DATA FORM.
 - a) FOR PETROLEUM SPILLS CALL 1-800-424-8802.
 - D) NOTIFY OFFICE OF FIRE PREVENTION AND CONTROL
1-518-474-6746
 - E) IT IS THE RESPONSIBILITY OF THE FIRE COORDINATOR TO NOTIFY THE COUNTY CHIEF EXECUTIVE, WHEN NECESSARY.
 - F) NOTIFY COUNTY HIGHWAY DEPARTMENT.
 - G) COMPLETE CHECKLIST SHEET AS INCIDENT ESCALATES OR TERMINATES.

TEAM ALERT PROCEDURES:

WHEN A HAZ-MAT INCIDENT OCCURS, AND THE INCIDENT COMMANDER FEELS IT NEEDS TO BE HANDLED BY THE ALLEGANY COUNTY HAZ-MAT TEAM(S), THE CALL WILL GO OUT IN THE FOLLOWING MANNER:

- 1) THE CALL WILL GO OUT OVER THE ALLEGANY COUNTY FIRE CONTROL RADIO SYSTEM. EX: ACTIVATE PAGER TONES & TEXT FOR HAZ MAT TEAM MEMBERS AND ANNOUNCE: **FIRE CONTROL TO ALL COUNTY HAZ-MAT MEMBERS - THIS IS AN ALERT, FIRE CONTROL (TIME).**

ON (DO NOT CALL THE FIRE CONTROL ON THE PHONE AND ASK WHAT IS GOING OR HAPPENING, AS THINGS WILL BE BUSY ENOUGH FOR THE DISPATCHER AT THIS TIME.)

- 2) THE HAZ-MAT TEAM MEMBERS RESPONDING WILL REPORT TO THE FIRE HEADQUARTERS THAT IS ASSIGNED THE EQUIPMENT FOR THEIR TEAM.
- 3) ONCE THE TEAM MEMBERS REACH THEIR INITIAL RESPONSE HEADQUARTERS, THEY WILL GET THEIR EQUIPMENT READY FOR FURTHER RESPONSE AND BEGIN TELEPHONE CALL-UP PROCEDURES FOR THEIR MEMBERS.
- 4) WHEN THE HAZ-MAT COORDINATOR GETS ON LOCATION OF THE INCIDENT, HE WILL BE BRIEFED BY THE ON-SCENE INCIDENT COMMANDER.
- 5) THE HAZ-MAT COORDINATOR WILL THEN MAKE A DETERMINATION AS TO WHETHER OR NOT THE TEAM WILL HANDLE THE INCIDENT.
- 6) IF THE DETERMINATION IS THAT THE INCIDENT CAN NOT BE HANDLED BY THE HAZ-MAT TEAM(S), THEN THE TEAM WILL BE PUT INTO A STANDBY STATUS BY THE HAZ-MAT COORDINATOR. AT THIS POINT THE HAZ-MAT COORDINATOR WILL REMAIN ON THE SCENE ONLY TO RENDER ASSISTANCE THAT MAY BE NEEDED WITHOUT HANDLING THE INCIDENT ITSELF. THE STANDBY STATUS FOR THE TEAM CONSISTS OF STANDING BY WITH THEIR EQUIPMENT AT THEIR TEAM HEADQUARTERS.
- 7) IF THE DETERMINATION IS THAT THE INCIDENT CAN BE HANDLED BY THE HAZ-MAT TEAM(S), THE TEAM(S) WILL RESPOND TO THE LOCATION THAT THE HAZ-MAT COORDINATOR REQUESTS.

NOTE: THE ALLEGANY COUNTY HAZ-MAT TEAM CAN ONLY BE REQUESTED DIRECTLY TO THE SCENE OF AN INCIDENT BY THE ALLEGANY COUNTY FIRE COORDINATOR OR ONE OF THE HAZ-MAT COORDINATORS.

RESPONSE LEVEL CRITERIA

A. **RESPONSE LEVEL I CRITERIA:** CONTROLLED EMERGENCY CONDITION

1. INCIDENT THAT CAN BE CONTROLLED BY PRIMARY FIRST RESPONSE AGENCIES OF LOCAL JURISDICTION.
2. SINGLE JURISDICTION AND LIMITED AGENCY INVOLVEMENT.
3. DOES NOT REQUIRE EVACUATION, EXCEPT FOR THE STRUCTURE OF AFFECTED FACILITY.
4. CONFINED GEOGRAPHIC AREA.
5. NO IMMEDIATE THREAT TO LIFE, HEALTH OR PROPERTY.
6. ACHMRT MAY BE REQUESTED.

B. **RESPONSE LEVEL II CRITERIA:** LIMITED EMERGENCY CONDITION

1. POTENTIAL THREAT TO LIFE, HEALTH OR PROPERTY.
2. EXPANDED GEOGRAPHIC SCOPE.
3. LIMITED EVACUATION OF NEARBY RESIDENT OR FACILITIES.
4. INVOLVEMENT OF TWO OR THREE JURISDICTIONS.
5. ACHMRT SHOULD BE REQUESTED.
6. LIMITED PARTICIPATION OR MUTUAL AID FROM AGENCIES THAT DO NOT ROUTINELY RESPOND TO EMERGENCY INCIDENTS IN THE AREA.
7. SPECIALIST ON TECHNICAL TEAM IS CALLED TO THE SCENE.
8. COMBINED EMERGENCY OPERATIONS SUCH AS FIRE FIGHTING AND EVACUATION, OR CONTAINMENT AND EMERGENCY MEDICAL CARE.

C. **RESPONSE LEVEL III CRITERIA:** FULL EMERGENCY CONDITION

1. SERIOUS HAZARD OR SEVERE THREAT TO LIFE, HEALTH AND PROPERTY.
2. LARGE GEOGRAPHIC IMPACT.
3. MAJOR COMMUNITY EVACUATION.
4. MULTI-JURISDICTIONAL INVOLVEMENT.
5. STATE AND FEDERAL INVOLVEMENT.
6. SPECIALISTS AND TECHNICAL TEAMS DEPLOYED.
7. EXTENSIVE RESOURCE MANAGEMENT AND ALLOCATION.
8. MULTIPLE EMERGENCY OPERATIONS.

DECLARING A RESPONSE LEVEL

THE ON-SCENE COMMANDER MAY DECLARE A RESPONSE LEVEL. IF A RESPONSE LEVEL HAS NOT BEEN DECLARED, THE HAZ-MAT COORDINATORS SHOULD PROVIDE ADVISE TO THE ON-SCENE COMMANDER IN DECLARING A RESPONSE LEVEL.

IF NECESSARY, THE HZ-MAT COORDINATOR MAY UNILATERALLY DECLARE A RESPONSE LEVEL FOR THE PURPOSE OF ACTIVATING AND COORDINATING THE ALLEGANY COUNTY HAZARDOUS MATERIALS RESPONSE TEAM. IN ALL CASES, THE FIRE COORDINATOR AND THE HAZ-MAT COORDINATORS SHOULD COORDINATE WITH THE ON-SCENE COMMANDER IN DECLARING A RESPONSE LEVEL.

RESPONSIBILITIES

A. RESPONSE LEVEL I:

1. RANKING OFFICER OF THE LOCAL FIRE DEPARTMENT SERVES AS ON-SCENE COMMANDER.
2. ON-SCENE COMMANDER ESTABLISHES LIAISON WITH THE FACILITY EMERGENCY COORDINATOR, OR DRIVER OR TRANSPORT VEHICLE.
3. ALLEGANY COUNTY FIRE CONTROL NOTIFIES THE FIRE COORDINATOR/ EMERGENCY MANAGER, AND HAZ-MAT COORDINATORS.
4. COMMAND POST IS ESTABLISHED, IF REQUIRED.
5. ON-SCENE COMMANDER EVALUATES THE NEED TO DECLARE A HIGHER RESPONSE LEVEL, IF APPROPRIATE.

B. RESPONSE LEVEL II:

1. RANKING OFFICER OF THE FIRE DEPARTMENT WITH PRIMARY JURISDICTION AND AUTHORITY SERVES AS ON-SCENE COMMANDER.
2. UNIFIED COMMAND ESTABLISHED.
3. COMMAND POST ESTABLISHED.
4. ON-SCENE COMMANDER EVALUATES THE NEED FOR A DEPUTY OR OTHER ON-SCENE ASSISTANTS SUCH AS: OPERATIONS OFFICER, COMMUNICATIONS ASSESSMENT, SAFETY, ETC.
5. ON-SCENE COMMANDER REQUESTS ALLEGANY COUNTY HAZARDOUS MATERIALS RESPONSE TEAM(S), (DISPATCH PROCEDURE - PAGE 3).
6. ALLEGANY COUNTY FIRE CONTROL NOTIFIES HAS-MAT COORDINATORS, FIRE COORDINATOR/ EMERGENCY MANAGER, DISTRICT DEPUTY COORDINATOR, SHERIFF, STATE POLICE, HEALTH DEPARTMENT, COUNTY HIGHWAY DEPARTMENT, NY OFPC, DEC, WELLSVILLE AND OLEAN HOSPITALS.
7. FIRE COORDINATOR/EM NOTIFIES AND BRIEFS THE LOCAL AND COUNTY CHIEF EXECUTIVE.
8. FIRE COORDINATOR/EM BRIEFS THE PUBLIC INFORMATION OFFICER, AND ACTIVATES THE PIO, IF NECESSARY.
9. FIRE COORDINATOR/EM AND CHIEF EXECUTIVE EVALUATES THE NEED TO DECLARE A LOCAL STATE OF EMERGENCY UNDER N.Y.S. EXECUTIVE LAW, ARTICLE 2-B.
10. FIRE COORDINATOR /EMERGENCY MANAGER DETERMINE IF THE NEED FOR ACTIVATION OF THE EMERGENCY OPERATIONS CENTER OR SPECIAL STAFF.
11. ON-SCENE COMMANDER, FIRE COORDINATOR/ EMERGENCY MANAGER, HAZ-MAT COORDINATORS, AND HEALTH DEPARTMENT EVALUATE THE NEED TO DECLARE HIGHER OR LOWER RESPONSE LEVEL.
12. ON-SCENE COMMANDER, FIRE COORDINATOR, EMERGENCY MANAGER, SHERIFF AND HEALTH DEPARTMENT EVALUATE THE EXISTING DESIGNATION OF THE ON-SCENE COMMANDER. THEY MAKE A RECOMMENDATION TO THE CHIEF EXECUTIVE WHO WILL DECIDE TO RETAIN THE EXISTING ON-SCENE COMMANDER OR DESIGNATE A NEW ON-SCENE COMMANDER BASED ON THE SCOPE AND TECHNICAL COMPLEXITY OF THE EMERGENCY.

C. RESPONSE LEVEL III:

1. DESIGNATION OF THE ON-SCENE COMMANDER SHOULD BE RE-EVALUATED AT THIS LEVEL BASED ON THE SCOPE AND TECHNICAL COMPLEXITY OF THE EMERGENCY. THE CHIEF EXECUTIVE WILL MAKE AN APPROPRIATE DESIGNATION AFTER CONSULTING WITH THE EXISTING ON-SCENE COMMANDER, , FIRE COORDINATOR EMERGENCY MANAGER /, SHERIFF, AND HEALTH DEPARTMENT.
2. FIRE CONTROL FOLLOWS LEVEL I AND LEVEL II NOTIFICATION PROCEDURES AND ACTIVATES THE COUNTY HAZARDOUS MATERIAL EMERGENCY PLAN.
3. UNIFIED COMMAND REQUIRED.
4. COMMANDED POST REQUIRED.
5. ON-SCENE COMMANDER WILL DESIGNATE A DEPUTY AND KEY ASSISTANTS AS REQUIRED. THEY MAY INCLUDE: OPERATIONS, RESOURCES, COMMUNICATIONS, HEALTH AND MEDICAL, TRANSPORTATION, ASSESSMENT AND EVALUATION, CONTAINMENT, AND EVACUATION OFFICERS.
6. SAFETY OFFICER REQUIRED.
7. CHIEF EXECUTIVE DECLARES A LOCAL STATE OF EMERGENCY UNDER N.Y.S. EXECUTIVE LAW, ARTICLE 2-B, IF APPROPRIATE.
8. EMERGENCY MANAGER/ FIRE COORDINATOR ACTIVATES THE EMERGENCY OPERATIONS CENTER.
9. PUBLIC INFORMATION OFFICER ACTIVATED.

- D. RESPONSE LEVEL III COULD BE OF THE MAGNITUDE THAT REQUIRES RESOURCES FROM New York STATE. THE STATE EMERGENCY MANAGEMENT OFFICE (SEMO) COORDINATES THE APPLICATION OF THE STATE'S RESOURCES IN AN EMERGENCY.

AT THIS RESPONSE LEVEL, UNIFIED COMMAND WOULD LIKELY INCLUDE STATE AND POSSIBLY, FEDERAL RESOURCES. LOCAL, COUNTY AND STATE OFFICIALS SHOULD RE-EXAMINE RESPONSE REQUIREMENTS AND THE DESIGNATION OF THE ON-SCENE COMMANDER AT THIS TIME.

- E. IN A RESPONSE LEVEL III EMERGENCY OR A STATE DISASTER EMERGENCY, THE COUNTY EXECUTIVE, EMERGENCY MANAGER, AND SENIOR STATE OFFICIAL(S) AT THE SCENE WOULD JOINTLY DECIDE WHETHER OR NOT TO DESIGNATE A STATE OFFICIAL AS ON-SCENE COMMANDER.
