TITLE: ADOPTION OF LOCAL LAW INTRO. NO. 10 - 81, PRINT NO. 1, TO AMEND LOCAL LAW NUMBER TWO OF NINETEEN HUNDRED SEVENTY-EIGHT TO SUBSTITUTE TITLE OF COUNTY SUPERINTENDENT OF PUBLIC WORKS FOR TITLE OF COUNTY SUPERINTENDENT OF HIGHWAYS

RESOLVED:

- 1. That proposed Local Law, Intro. No. 10 - 81, Print No. 1, is hereby adopted without any change in language, to wit:

A LOCAL LAW TO AMEND LOCAL LAW NUMBER TWO OF NINETEEN HUNDRED SEVENTY-EIGHT TO SUBSTITUTE TITLE OF COUNTY SUPERINTENDENT OF PUBLIC WORKS FOR TITLE OF COUNTY SUPERINTENDENT OF HIGHWAYS

BE IT ENACTED by the Board of Legislators of the County of Allegany as follows:

Section 1. Sections one and two of local law number two of nineteen hundred seventy-eight are hereby amended to read as follows:

Section 1. No civil action shall be maintained against the county of Allegany or the county superintendent of public works for damages or injuries to person or property sustained in consequence of any street, highway, road, bridge, culvert, sidewalk or crosswalk being out of repair, unsafe, dangerous or obstructed, or in consequence of the existence of snow or ice thereon, unless written notice of the defective, unsafe, dangerous or obstructed condition, or of the existence of such snow or ice, was actually given to the clerk of the county board of legislators and there was a failure or neglect within a reasonable time after the giving of such notice to repair or remove the defect, danger or obstruction complained of, or to cause the snow or ice to be removed, or the place otherwise made reasonably safe.

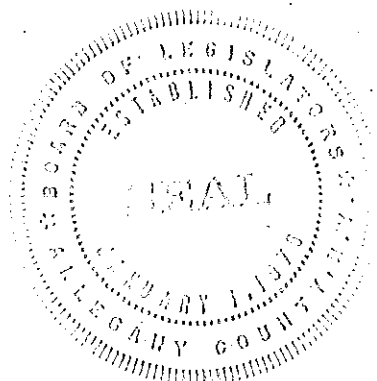
