**County Historian**

County Historian Craig Braack attended the meeting and submitted his monthly report to the committee for review. Mr. Braack stated they have started installing the new portable files and apologized for the displacement Child Support will incur.

**Soil & Water Conservation**

Soil and Water Conservation Executive Director Scott Torrey was unable to attend the meeting but submitted his monthly report to the committee for review.

**Youth Bureau**

Youth Bureau Director Linda Edwards attended the meeting and submitted her monthly report for the committee to review. Ms. Edwards stated all Youth Bureau contract agencies have been paid by the County, and we are among the first in the state to have it completed. Ms. Edwards stated the Dan Barkley Showcase games were rescheduled due to the weather. There were three games played on Sunday afternoon, and Allegany County won two of the three games. Ms. Edwards continued that attendance wasn't bad, they had a great showcase that was well received, and they were happy to be a part of it. **Cornell Cooperative Extension**
