It is further agreed that any and all movements will be made in the manner provided by law, and in accordance with the conditions and regulations as hereinafter set forth, all forming a part hereof in which the applicant agrees in the acceptance of this permit to assume all responsibility and liability for damages to persons and/or property that may accrue during such movements through the negligence himself, his agents or employees, or from any other cause and have the County of Allegany harmless therefrom. **A current Certificate of Liability must be submitted with permit.**
